- 2. I am familiar with the facts and circumstance of this Article 78 challenge of a preliminary subdivision approval from my review of the verified petition, the records maintained by the Town and my discussions with employees of the Town of Smithtown who were involved in the review of the subdivision application.
- 3. This affirmation is submitted in support of the Town's motion to dismiss the verified petition on the ground that none of the individual petitioners can demonstrate the requisite standing to challenge the Town's determination as evidenced by aerial maps showing distances from the petitioners' properties to the development area.
- 4. In addition, the Village of Head of the Harbor is barred as a matter of law from being a party as evidenced by the Village Board of Trustees' Resolution #02-22 which does not properly authorize the retention of the firm of Ruskin Moscou Faltischek, P.C.; and does not property authorize the commencement of this Article 78 proceeding against the Town of Smithtown or any of its agencies or officials.
- 5. Further, the Town respondents submit that petitioner Judith Ogden suffers from a serious conflict of interest that cannot be waived by the Village of Head of the Harbor and as a result she may not serve as a party to this proceeding.
- 6. Annexed hereto as Town Exhibit 1 is a copy of the verified petition without the voluminous exhibits. Annexed hereto as Town Exhibit 2 is a copy of an aerial map depicting each petitioner's property and the distance from the development site in the preliminary subdivision (referred to hereinafter as "the Gyrodyne property").
