New York, hereby affirm under penalties of perjury:

1. I am a Partner with Certilman Balin Adler & Hyman, LLP, attorneys for

Respondents Gyrodyne, LLC and Gyrodyne Company of America, Inc. (collectively, "Gyrodyne")

and, as such, I am fully familiar with the content and materials described herein.

2. I make this affirmation in support of Gyrodyne's objections in point of law against and motion to dismiss, pursuant to CPLR 7804(f) and CPLR 3211(a)(1) and (7), respectively, ("Motion"), the above-named Petitioners' Petition, dated and verified April 25, 2022 ("Petition"),<sup>1</sup> on the grounds the Petitioners lack standing and their allegations are refuted by the documentary evidence and fail to state a claim.
